1. Who we are

The Engineering Council is the UK regulatory body for the engineering profession. The Engineering Council is a registered charity, number 286142, whose registered office is 10 Lower Thames Street, London EC3R 6EN.

2. Personal Data

2.1 What is personal data

Personal data is any information that can be used to identify an individual.

2.2 What personal data do we collect

The personal data that the Engineering Council collects and processes on you is:

2.3 What we use your personal data for

The personal data we collect will be used for the following purposes:

- To submit your application for registration under the Mutual Recognition Agreements (MRA).
- To create a record of your application.
- For statistical generation, reporting and analysis of the data held on the International Register. All reports are anonymised so that they do not contain any personal data.

2.4 What is the basis for processing your data

The processing of your personal data by the Engineering Council is conducted on the basis of legitimate interest in order to facilitate your application under the Mutual Recognition Agreement and all associated processes as outlined in 2.3.

2.5 Special or sensitive data

The Engineering Council does not collect or process special categories of personal data or sensitive data such as race, ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, etc.

3. Consent

There is no requirement for your consent to process your personal data as specified in this Notice unless it is outside the basis of legitimate interest.

4. Sharing your data

The Engineering Council will pass your personal data to the following third parties, without first obtaining your consent, for the following purpose(s) as part of our processing activities:

Ordem Dos Engenheiros	To initiate the process of professional registration in Portugal under the MoU
KIVI	To initiate the process of professional registration in the Netherland under the MRA
AIPE	To initiate the process of professional registration in Spain under the MRA
AQPE	To initiate the process of professional registration in Cataluña under the MRA
Idaho Board	To provide the Idaho Board with a letter confirming your professional registration and good standing for application under the Comity Provision
NCEES	To initiate the process of professional registration in the participating US States under the MRA

The Engineering Council will not pass on your personal information to any other organisation.

5. Retention

The Engineering Council will continue to hold the record of your application indefinitely.

6. Your rights as a data subject

At any point while we are in possession of, or processing your personal data, you, the data subject, have the following rights:

- **Right of access** – you have the right to request a copy of the information that we hold about you.
- **Right of rectification** – you have a right to correct data that we hold about you that is inaccurate or incomplete.
- **Right to be forgotten** – in certain circumstances you can ask for the data we hold about you to be erased from our records.

- **Right to restriction of processing** – where certain conditions apply to have a right to restrict the processing.
- **Right of portability** – you have the right to have the data we hold about you transferred to another organisation.
- **Right to object** – you have the right to object to certain types of processing such as direct marketing.
- **Right to object to automated processing, including profiling** – you have the right to be object to the legal effects of automated processing or profiling.
- **Right to judicial review** - in the event that the Engineering Council refuses your request under rights of access, we will provide you with the reason why. You have the right to complain.

If we receive a request from you to exercise any of the above rights we will forward them on, as appropriate, to any third party involved (as stated in section 4 above) in the processing of your personal data.

8. Complaints
