

International Engineering Technician (IntETn (UK))

Registration Application Form

Admission to the UK Section of the International Register of Engineering Technicians is open to registered Engineering Technicians (EngTech) and Information and Communications Technology Technicians (ICTTech) who:

- Have at least one year of Engineering experience since graduation,
- And who are undertaking relevant Continuing Professional Development (CPD).

This form should be used by applicants who have been registered with the Engineering Council for more than 12 months. If you have been registered as an EngTech or ICT*Tech* for less than 12 months please contact the Engineering Council before applying via your registering institution.

This form, plus supporting documentation, must provide the Engineering Council with sufficient evidence to enable compliance with these requirements to be quickly and effectively assessed and verified. Applicants should ensure they have read the accompanying guidance notes before completing this form (in black font only).

- Detailed CPD record covering the 2023 and 2024
- A copy of each of your certificates for any engineering or ICT technician education undertaken.
